



## **Call for Expressions of Interest: Chartered Professional Assessor**

*Contribute to the AusIMM community, increase your networks and extend your professional development. The Chartered Professional Assessor role is well regarded by employers and can benefit your career.*

### **Background**

A reformed AusIMM Chartered Professional Program (CPP) will commence on 1 January 2018. To support the new program the AusIMM is seeking expressions of interest for the team of volunteer Chartered Professional Assessors, who will assess CPP applications and conduct Professional Development (PD) reviews.

Expressions of Interest applications are open on an ongoing basis, and applicants in the disciplines of Environment and Management in particular are encouraged to apply.

### **Chartered Professional Assessor role**

Chartered Professional Assessors use their discipline specific skills and experience to assess applications for the AusIMM Chartered Professional Program and Board of Professional Engineers of Queensland (BPEQ) registration and conduct Professional Development (PD) reviews of CP members.

Chartered Professional Assessors are volunteers of the AusIMM, and report to the Chartered Professional Program Committee (CPPC).

It is expected that an Assessor will undertake training (commencing in September/October 2017); and the processing of CP application assessments, PD reviews and related administrative work which will involve approximately 2-3 hours of work per month.

### **Eligibility and Application Requirements for Chartered Professional Assessors**

Applicants for Chartered Professional Assessor must:

- be a current AusIMM Chartered Professional with at least 5 years' experience as a CP in their selected CP discipline;
- demonstrate at least 5 years' recent experience in the CP discipline applied for by submitting a detailed, current CV, plus a statement of no more than 150 words outlining their professional background and experience, along with any relevant involvement with AusIMM activities;
- demonstrate a commitment to being a CP Assessor by providing a statement of no more than 150 words outlining why they wish to become a Chartered Professional Assessor, and the contribution they would like to make;
- upon application, pass a Professional Development (PD) review; and
- provide the endorsement of three supporters who are also Chartered Professionals, two of whom must be in the same CP Discipline.
